1.0 INTRODUCTION

- 1.1 WPD provides instructions to staff involved in activities relating to consents and wayleaves via Practice Notes.
- 1.2 This ST relates to the status and management of Practice Notes. The effect of this ST is to make Practice Notes formal Company policy relating to consents and wayleaves activities.
- 1.3 'Consents and wayleaves' includes (though not exhaustively):
 - Purchase of land and rights over land for operational purposes.
 - Statutory consents for operational purposes, including planning permission (e.g. overhead lines and sub stations) and environmental consents.
 - The assessment of claims for compensation relating to operational works and operational apparatus on private land.
- 1.4 Practice Notes are usually focussed on a single topic and have a concise format. They are maintained on the Consents & Wayleaves intranet site (which can be accessed through the Logistics home page).

2.0 **RESPONSIBILITIES**

- 2.1 Practice Notes are produced by the Consents & Wayleaves team (in the light legal advice where relevant) and owned by the Consents & Wayleaves Manager. They are authorised by the Logistics Manager or the Consents & Wayleaves Manager.
- 2.2 A register of Practice Notes is maintained by the Consents & Wayleaves team which records details about their publication and authorisation history. The Register is owned by the Consents & Wayleaves Manager.
