Meeting organisations in the region

It's been great to meet so many of you over the past few months. We recently met with Dorset Community Energy to discuss their **Energy Local Bridport project.**

This project enables local energy customers to buy locally generated renewable energy from the Salway Ash wind turbine.

We were pleased to share how the new charging arrangements, resulting from the Significant Code Review (SCR) (explained further below), could reduce connection costs for future generation projects. We also valued meeting with many other organisations from across our region, including Harbury Energy Initiative (Warwickshire), Marshfield Energy Group (Gloucestershire), Sustainable South Hams (Devon), Harborough Energy (Leicestershire), Cardiff City Council, Devon County Council and West Midlands Combined Authority.

Connecting to the National Grid distribution network

Update from Kyle Smith, Connections Strategy Engineer, **National Grid**

2022 saw National Grid achieve some significant milestones in its journey, including the launch of our **online self-service budget estimate tool** for low voltage connections, engaging with a wide range of stakeholders and community energy groups at multiple events, and enhancing our **connections website** to provide better support and guidance for customers through the application process for generation and demand connections.

Changes in connection costs

In 2023, the way we charge for connecting to our network is changing. Following Ofgem's Access and Forward-Looking Charges Significant Code Review (SCR), a new approach to connection charges will be effective for applications received on or after 1 April 2023.

These changes mean customers applying for demand connections (e.g. heat pumps and EV chargers) will no longer pay a proportion of network reinforcement costs, and electricity generation customers will only pay a proportion of reinforcement costs at the same voltage level as their connection (for a beginner's guide to the electricity network, **see here**).

Both, however, may still need to pay for reinforcement if they are calculated to be very high cost. In addition, a network installed just for a particular site will still be fully charged to the customer, either by the Distribution Network Operator (DNO) or an Independent Connection Provider (ICP). Self-service web tools

This year we will be rolling out further self-service web tools for our customers. We have recently launched our domestic electric vehicle charger application tool which instantly acknowledges the installation of an EV charger without needing an application to be sent to our teams for processing.

We've had nearly 500 applications in the three months since the tool went live. We'll also enhance the self-service budget estimate tool to give customers the option of receiving a firm connection offer that can be accepted and progressed to construction.

Net Zero Communities Strategy

Our 2023 Net Zero Communities strategy will be coming out shortly. This will outline our commitments for the next year and how we are planning to support the community energy sector in our region. Keep an eye on **our website** for more information.

Ofgem local energy consultations

Two consultations that are relevant to community energy stakeholders have recently been announced.

The first is the "Future of Local Energy Institutions and Governance" consultation. This is a consultation on how to provide stronger, clearer allocations of local responsibilities concerning the planning, market facilitation and operation of energy.

The second is the "Future of Distributed Flexibility" call for input. This is a call for input from stakeholders across the industry to build a "common vision for distributed flexibility" and help tackle the market access and coordination issues.

In the coming year, we will use these newsletters to highlight some supportive resources we've developed over the past few years. This time, it's the carbon tracer app.

National Grid: Carbon tracer app

We wanted to create an application that uses real, live data to calculate what contributes to the locally generated energy that powers the electric items in your home.


Carbon Tracer helps users understand where their electricity comes from and how much CO² was produced from its generation.

This app also informs users on how the carbon intensity of their electricity changes within the day and across the week.

Users could try moving their use of energy intensive appliances (e.g. washing machines, tumble dryers, dishwashers, or water heaters) to periods of lower carbon intensity (green times on the forecast screen).
