Community energy in our business plan

For our next business plan, 2023-28, we submitted an ambitious plan to drive net zero by as early as 2028 across our region, requiring an investment of £6.7 billion – without raising consumer bills. We encountered some challenge to this in Ofgem's draft decision so we have spent the last few months considering how that might impact our commitments and plans.

We hope that Ofgem's final decision, this month, will allow us to invest as planned. In the meantime, you can read our 'RIIO ED2' plan **here**.

Community energy spotlight

Power Allotments Devon

Power Allotments Devon is a new not-for-profit collaboration between Regen and community energy company Devon Energy Community Interest Company (CIC), funded by Devon County Council.

The project aims to deploy local renewable 'power stations' across Devon, whilst bringing the financial benefits to local communities.

Local people are encouraged to identify areas of land that they think may be suitable for a parish-scale solar farm or a commercial-scale wind turbine that would be community owned.

An interactive map has been designed to help rule out unsuitable areas such as places that are too far from our electricity network or fields better used for food production. At a time of unpredictable energy prices and the wider cost of living crisis, it is an opportunity for communities to take control of local energy infrastructure and retain the economic benefits locally.

The vision is for every community to own a local energy site that can also be managed for biodiversity, becoming a haven for wildlife.
