





Welcome to the latest quarterly update from Western Power Distribution (WPD) on community energy. In this edition, you will find news from across the sector, new funding opportunities and changes to look out for here at WPD.

We enjoyed catching up with many of you at our in person Net Zero Communities Forums in Cardiff and Nottingham in June, where discussions focused on the opportunities for community projects to connect to the network, ideas for innovation projects and how WPD can help facilitate partnerships between community energy groups and local authorities.

We hope that you found the updates and opportunities for networking useful, and we will be following up on many of the actions that came from those sessions over the coming months.

Net Zero Communities Forum, Butetown Community Centre, Cardiff – 9th June 2022

### Community Energy State of the Sector 2022

Community Energy England, Wales and Scotland have launched the 2022 State of the Sector report, which gives an annual overview of the community energy sector across the UK, describing how the sector is changing, examining barriers to projects, and providing an evidence base to advocate for community energy locally and nationally. Highlights from the last 12 months include:

- 18 new community energy organisations being formed across the UK;
- an estimated 217,489 people being engaged with by the sector;
- and 7.5 MW of new renewable energy capacity being installed, bringing the total to 331 MW of community owned capacity in the UK.

### Local energy policy paper

Power for People, the campaigning organisation behind the Local Electricity Bill which aims to give electricity generators the right to become local suppliers, have published a policy paper setting out alternative proposals for local supply.

This includes mechanisms such as a Community Electricity Export and Supplier Services Guarantee, designed to support community energy and local electricity markets.

### WPD at Stithians Energy Group conference

On 28th May, WPD was invited to speak at the Stithians Energy Group seminar in Cornwall, as part of our commitment to accelerating net zero in communities across our region. We discussed the support available through the Community Energy Engineer and focused on the future of the network and grid capacity in Cornwall, with 94 people in attendance at the event.

### WPD appears at Historic England conference

We were also invited to speak at the Future of Heating in Historic Buildings conference in London on 28th June. The electrification of heat is key to reducing reliance on fossil fuels in historic buildings on our way to Net Zero.

WPD gave a perspective on how consumers could be turned into 'prosumers' and how the flexibility services we offer could be delivered by communities. We also discussed the commitments we have made to our communities as part of our RIIO-ED2 Business Plan.

### Spotlight on innovation

On 30th June, WPD's Innovation Team held the #28toZero event in London, focusing on the value of energy efficiency to WPD, other DNOs and customers, and how vulnerable customers should be protected in the energy transition.

We also presented the work that has been done to analyse how suitable current energy market structures are for achieving a fair net zero, along with further talks on decarbonising heat and flexibility in heating.

#### **Energy Redress Funding**

Energy Redress Scheme remains open to community groups, with grants over £20,000 to support local net zero projects and fuel poverty work. You can register your organisation.

#### Fast start innovation funding competition

Small businesses that have not previously received Innovate UK funding can enter the Fast Start: Innovation funding competition and apply for grants up to £50,000 for innovative ideas in net zero. The competition closes on 26 July.
